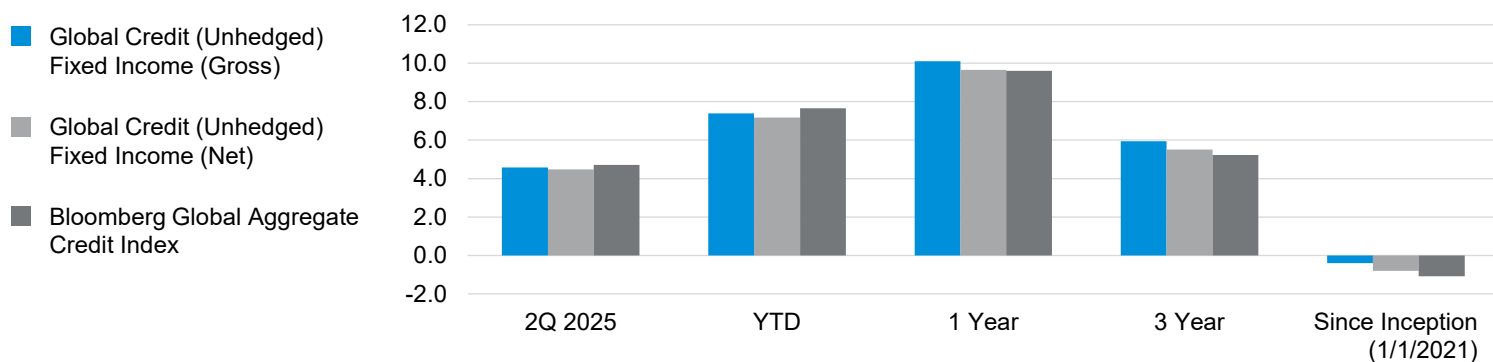

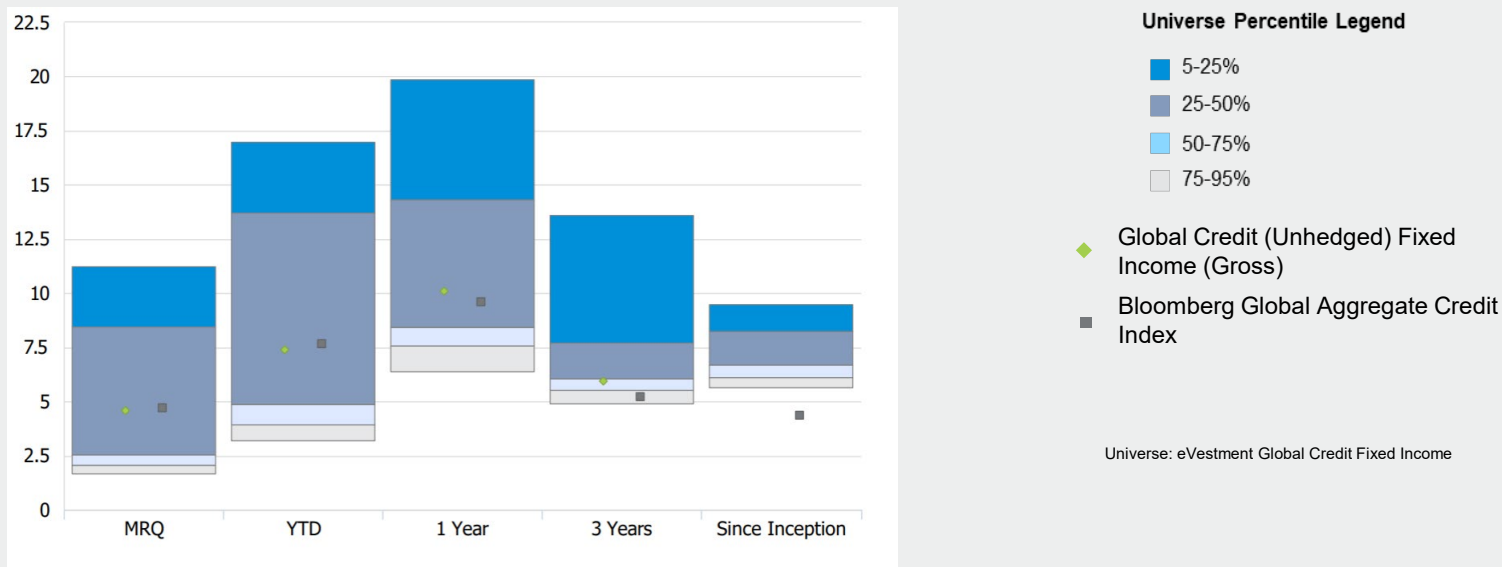

The Global Credit strategy seeks to outperform the benchmark by investing in fixed income securities of credit issuers worldwide. The Global Credit Fixed Income ("Global Credit") Composite contains all portfolios managed on a discretionary basis according to the applicable composite strategy except as otherwise excluded herein. The Firm maintains a list of composites and descriptions, a list of limited distribution pooled funds and their descriptions, and a list of broad distribution pooled funds, all of which are available upon request. Policies for valuing investments, calculating performance, and preparing GIPS® reports are available upon request.

The performance benchmark for the Global Credit Fixed Income ("Global Credit") Composite is the Bloomberg Global Aggregate Credit Index, which measures the global investment grade local currency corporate and government-related bond markets. Net-of-fee returns reflect the deduction of investment management fees and are calculated in the same manner as gross-of-fee returns. The investment management fee schedule for the Global Credit strategy is 0.40% on the first \$25 million, 0.35% on amounts from \$25 million to \$50 million, and 0.30% on the remaining amount. Net returns have been calculated by reducing the monthly gross returns by the twelfth root of the highest stated fee of 0.40% in the Firm's ADV. Investment management fees are described in greater detail in the Firm's ADV. 100% of the composite assets are comprised of non-fee-paying portfolios for the periods presented. Individual client returns will be reduced by investment management fees and other expenses that the account may incur. Fees have a compounding effect on cumulative results.
