INVESTMENT APPROACH³

- Risk is continuously evaluated and managed at the portfolio, sector and security levels.

INVESTMENT STRATEGY³

The STAMP 1-5 Year strategy seeks to provide institutional investors with principal preservation, maintenance of liquidity as well as income and capital appreciation through a business cycle with the goal of generating consistent, attractive risk-adjusted returns. Allowable investments include investment grade securities in the U.S. government, agency, corporate credit, bank loan, mortgage and assetbacked and municipal bond sectors as well as money market instruments.


